

**THE INSTITUTION OF ENGINEERS, SRI LANKA (IESL)**

APPLICATION FOR REGISTERING AS A STRUCTURAL ENGINEER FOR THE DESIGN OF BUILDINGS WITH MORE THAN 4 FLOORS AS PER THE REQUIREMENTS OF THE URBAN DEVELOPMENT AUTHORITY

**NOTES TO APPLICANTS**

1. As per the requirements of the Urban Development Authority (UDA) it has become necessary for the Corporate Members in the field of Civil Engineering to register with the Institution in order to be eligible to carry out structural designs of buildings with more than 4 floors. Interested members are requested to apply for registration using this application form.
2. The duly filled application form has to be accompanied by a brief CV of the applicant and an application processing fee of Rs. 2,750/=. Please note that an application once received at the IESL Secretariat would be processed only if the member has settled his/her subscription fees up to and including the year he/she requests registration for. The successful applicants will be requested to pay a fee of Rs. 1,500/- to get their names listed in the Directory of Structural Engineers.
3. Once an application is received from a member who has settled all his/her subscription fees due from him/her, it will be referred to a panel of senior structural engineers for evaluation. The panel will, inter alia, consider the following criteria when evaluating the application for its suitability.
  - a. The applicants previous design experience in the category of buildings applied for: The member applying in respect of buildings with more than 4 floors should have not less than one year of comprehensive experience of designing buildings of that category and prove that he/she has carried out the complete design of such buildings verified and countersigned by either a senior structural engineer who supervised the work concerned or by a structural engineer who has personal knowledge of the ability and competence of the applicant to do the type of structural designs indicated. The verifying engineer himself/herself should have been registered with the Institution under the particular building category.
  - b. The degree of responsibility and involvement in the designs done
  - c. Employment record
  - d. Knowledge on engineering fundamentals
  - e. Familiarity & use of current design codes in carrying out the design work
  - f. Awareness on safety aspects and precautionary measures to be adopted , especially in respect of excavations and foundations
  - g. Basic approach to foundation design

- h. Relevant postgraduate qualifications, if any
  - i. Willingness to seek advice in case of doubt or unfamiliarity
  - j. Interest in Continuing Professional Development
  - k. Sincerity and commitment with which the designs are undertaken using an ethical approach and avoiding risks
  - l. Any other relevant experience
4. If a member fails to provide all the information requested, his/her application is liable to get rejected.
  5. If the panel so decides, the applicant would be called for a discussion with the panel.
  6. The successful applicants will be requested to pay a fee of Rs. 1,500/= to get their names listed in the Directory of Structural Engineers and become eligible to carry out the structural designs of buildings in their respective categories for the year concerned.
  7. Once registered, it is the applicant who will be held personally responsible or liable for the designs he/she does and other engineering work the he/she authorizes or certifies and not the organization he represents or the Institution,.

Note: It is mandatory for structural engineers to use the seal in their official correspondence and in certification of drawings. Seals will be issued by the Institution on request for a fee of Rs. 1,000/- This seal will not carry an expiry date. The members are advised to refrain from using the seal if he/ she has ceased to be a member of the Institution for nonpayment of subscription fees or on disciplinary grounds.
