

USING MANAGEMENT INFORMATION SYSTEM FOR PROFESSIONAL REVIEW (PR) PROCESS

The IESL Charter is unarguably every Engineers' dream in their professional carrier. Chartered Engineers are academically-qualified to *well established standards* and have gained the highest level of professional competencies through specified periods of monitored training and professional practice. Finally they are peer-reviewed (Professional Review - PR) and take a solemn path to abide by a Professional Code of Ethics & Conduct.

During PR process for Feb/March 2021, IESL Membership Division was able to fully use MIS to initiate and track. This is the first time to use the fully computerized system for PR and the system was used for calling applications, reviewing documents, nominating panels for checking eligibility of candidates, providing comments and even conducting Interviews.

PROFESSIONAL STANDARDS MANAGEMENT COMMITTEE (PSMC) DEVELOPED A MECHANISM FOR RECOGNIZING *CIVIL* ENGINEERING CONSTRUCTION EXPERIENCE GAINED BY CANDIDATES WHO WORKED IN NON-IESL RECOGNIZED COMPANIES IN SRI LANKA AND OVERSEAS.
